Tricia Berry - Take 2 from Texas: Do they have term limits? How long will a girl stay on the board before it's time for new people to join in?

Karen Peterson: I loved that photo!

Erin Hogeboom: Tricia, that idea is 'part' of Helen's idea--engaging girls mostly

Carol Tang: if they would like some college application tips, that kind of thing, I'm sure us adults would be happy to hop on as well

Erin Hogeboom: Right now, we are trying to build critical mass, so we are open to as many girls.

Erin Hogeboom: Haha, #WhatOliviaSaid

Erin Hogeboom: Oh, that's a great idea, Carol!

Erin Hogeboom: Another one of the 'initiatives' is to connect them with mentors/role models

Tricia Berry - Take 2 from Texas: Are you connecting in with SWE Next at all?

Erin Hogeboom: We haven't! But we should be!

Erin Hogeboom: Thanks for the ideas!!

Carol Tang: tips on how to construct an email to connect with mentors...I think it's different than writing texts!

Erin Hogeboom: Absolutely, Carol!

Tricia Berry - Take 2 from Texas: Yes! Seems duplicative in nature a bit since it seems to be moving into the realm of girl-serving efforts.

Carol Tang: they can teach me how to text without full sentences

Erin Hogeboom: Like Olivia said, our first goal is to really build a sense of community, but I love this idea of giving them development like that!

FabFems Discussion Board

What are some ways we can identify additional FabFems for the database from your state?

Tricia Berry - Take 2 from Texas: Reach out to all who are also signed up as Million Women Mentors.

Susan: Connect with WV based women in STEM professional organizations. We have been working to do this but is still a work in process. Connect with universities.

Tricia Berry - Take 2 from Texas: STEMconnector CEO changed but Edie still involved. New CEO sounds like has some bigger picture strategy thinking that may help with collaborations.... maybe

Susan: That's wonderful!!!

Tricia Berry - Take 2 from Texas: or magically state leads can pull lists...so engaging MWM state leads directly might work

Carol Tang: we could maybe table at the meet-ups that happen all over San Francisco.

Lisa Kovalchick, PA: I always talk about FabFems in all the Girls in STEM presentations that I do, and I pass out FabFems info. Maybe we can remind others to do this, as well.

Tricia Berry - Take 2 from Texas: that's what we do in Texas...way easier to circumvent national and deal local - state leads have access to all the data

Casi Herrera: Great idea, Lisa. And if you think you need resources for this, let me know. We have outreach materials to share.

Carol Tang: Maybe interesting to link with WeWork and Hub, other communal workspaces. I've seen that a lot of women in tech are independent contractors and may not be in typical corporate settings.

What feedback have you heard from FabFems or role models in general about what makes their experience meaningful?

Tricia Berry - Take 2 from Texas: Being able to connect directly with students.

Casi Herrera: Absolutely!

Tricia Berry - Take 2 from Texas: need some sort of regular communication to them to even let them know they are still in the database...even if they haven't been contacting remind them their profile is important. maybe report out number of searches and things like that to make them feel like their engagement and profile is important to have in there

Casi Herrera: I am also curious about what other sources role models might use to connect with youth and programs.

Tricia Berry - Take 2 from Texas: Casi: Nepris (and in Texas...Texas STEM Connections) ...how we're connecting role models to programs and volunteer needs

Tricia Berry - Take 2 from Texas: Oregon, North Carolina (parts), Louisiana, and Texas all are using Nepris

Linda Kekelis: We could use social media to promote role models that want to be contacted but haven't been getting much traction

What needs are you hearing about from programs for role models?

Linda Kekelis: For groups working in rural communities, I hear about the need for role models--especially for role models from their communities--so that STEM careers aren't perceived as taking girls away from home and their communities

Erin Hogeboom: San Diego Unified School District REALLY wants to be able to use FabFems/STEM Role Models as their go-to place for professionals to visit classrooms.

Lisa Kovalchick, PA: I agree with Linda. Many of the programs that we work with are from rural areas and there are not FabFems located nearby to participate in role model activities.

What organizations (professional/technical, etc.) can we contact to help build the FabFems database.

Tricia Berry - Take 2 from Texas: All engineering discipline societies -- many have women -focused committees or sub-organizations

Erin Hogeboom: Putting this here so you all are aware, I just had a call with the International Association of Privacy Professionals (IAPP) about FabFems!

Carol Tang: game developers? I've seen a lot of interesting women and girl-focused gaming efforts at the Game Developers' Conference.

Casi Herrera: Very interesting, Carol. That's a great connection.

Susan: Last year had an opportunity to present at the National Women Engineers conference. There were over 50,000 people there, it was crazy! You could sponsor, have a booth, etc.

Susan: The conference had lots of professionals, lots of recent grads looking for jobs, also every employer you could imagine hiring Nike, Amazon, FBI, Nabisco, etc.

Lisa Kovalchick, PA: Have you contacted NCWIT?

Carol Tang: Maybe linking to some of the badging and micro certification things happening in afterschool. Many people could use some mentoring and coaching.

Casi Herrera: That is a great suggestion, Susan.

Susan: electronic and hardcopy would be good for us. Yes, we could use hardcopy.

Carol Tang: I think hard copies are still helpful. I just had a thought that maybe we could also laminate some for tabling.

Tricia Berry - Take 2 from Texas: Like Carol's idea. If we had this in high-res format we could make in slightly bigger poster size also.
